The Canada Science and Technology Museum has an extensive collection of historic medical artifacts in its storage facilities. The collection (over 1500 artifacts) covers a wide range of instruments from early monaural stethoscopes to Osler's student microscope to a complete 1993 Phillips MRI machine. In addition, we are presently processing the rich University Health Network Collection, which came to us from Toronto in 2002. Visitors will survey a selection of medical instruments amidst hundreds of shelves representing our other collections in communications, transportations, science, computing, natural resources and domestic technology.
